



## **REGISTRATION FOR PEDESTRIAN BIOMETRICS ACCESS CONTROL**

All pedestrians (Residents and Employees) that want to use the turnstile gates at Seaward Estates need to register with the Biometrics Fingerprint recognition system.

**The registration process requires a printed copy of the applicant's ID Document / Driver's License/ Passport to accompany the application.** Without an ID/ Driver's License/ Passport Document, registration cannot proceed. ID documents is not required for minors. The *locus standi* of minors would be established with their parents.
